

The Team shall keep watch on movement of illicit liquor, items of bribe, or large amount of cash, arms and ammunition and also movement of antisocial elements in the area. The entire process of checking shall be video graphed.

The entire operation by SSTs shall be done in the presence of an Executive Magistrate and shall be video graphed. No such checking shall take place without the presence of Executive Magistrate. The SSTs shall send a Daily Activity report to the S.P with copy to R.O., D.E.O and the Expenditure Observer, General Observer, and Police observer as per Annexure -C.
