ANNEXURE-A

GENERAL TERMS AND CONDITION:-

(a) Sealed tenders are invited for the design of 50 m tall-guyed tubular masts (6 numbers-designs approved and validated by competitive authority), its fabrication, transportation, civil works and installation in the Leh District of J&K state. An indicative specifications and details to be followed and supplied are given in Annexure -B&C. The tender should be completed in all respect and submitted in duplicate. The rates should be quoted as in the Annexure - E (enclosed). In Annexure - E the Profile of the Company and Undertaking to be furnished. The cover should be super-scribed as "Tender for design, fabrication, transportation, civil works and installation of 6 Nos. of 50 m tall guyed mast in the region of "LADAKH", J&K state and it should be delivered by person/post at the office of the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt. on or before **02-07-2010** upto **2.00 PM** It is the sole responsibility of the tenderer to ensure safe and timely delivery of the tender to **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt.** No consideration will be given if the tenders are lost or are delayed during transit. Tenders received after the due time and date will not be accepted.

(b) Tenders should be received upto **2.00 p.m. on 02-07-2010**, which will be opened at the same day or any other day convenient to the member of the committee at the office of **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt.** in the presence of the tenderers who wish to be present at the time of opening. The representatives of the tendering firms desirous of attending the tender opening should bring an authorization letter from their respective firms. If the due date is declared as a holiday, the tenders will be received and opened on the immediate succeeding working day without any change in the timings indicated.

(c) If the tenderer has any doubt regarding the meaning of any portion of this tender enquiry or finds any ambiguity in any of the terms and conditions stipulated in this enquiry, he shall get it clarified from the office of **Project Director, LREDA-LAHDC, Leh Ladakh** before the submission of his tender. If this is not done and subsequent to the opening of the tenders, it is found that the doubts about the meaning or ambiguity in the interpretation of any of the terms and conditions stipulated are raised by the tenderer either in his tender or by a separate letter, the interpretation or clarification issued by the authorities of **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** of such of those terms and conditions of the enquiry as may be raised by the tenderer shall be binding on the tenderer.

2. RIGHTS OF THE DEPUTY COMMISSIONER/CEO, LAHDC-LEH LADAKH:-

The **Deputy Commissioner/CEO, LAHDC, Leh-Ladakh** reserves the right to: -

- a. Accept the lowest or any tender.
- b. Revise the quantities at the time of placing order
- c. Relax or waive any of the conditions stipulated in the tender enquiry wherever deemed necessary in the best interest of **Project Director, LREDA-LAHDC, Leh-Ladakh** for good and sufficient reasons to be recorded in writing. The competent authority to decide the tender reserves this right.
- d. Reject any or all the tenders without assigning any reasons thereof.
- e. Award the contract to one or more tenderers.

3. REJECTION OF TENDERS:

The tender is liable to be rejected if it is:

- a. Not properly signed by the tenderer
- b. From any black-listed firm or contractor
- c. Received by fax or telegram
- d. Received after the expiry of the due date and time.
- e. Not in conformity with Terms and Conditions of Tender enquiry
- f. Found that the past performance of the tenderers is not satisfactory.
- g. Incomplete and evasive

4. COMPLETENESS OF TENDER:

(a) The tender should be completed with details of materials used for each items /components and quantity required to fabricate a 50 m high tubular mast including foundation bolts and the civil works, specifications used and descriptive literature and drawing. The details regarding the installation of the mast and the equipments required for its installation is also to be included with illustration.

(b) The details including drawing & specifications of weather proof housing for data logger, sensor booms and other hardware used for fixing anemometers, wind vanes, temperature and solar radiation sensors, details of lightening arrestor including earthing kit should be a part of the tender. Two-earthing kit (copper wire and copper rods) provision, one for mast and another for data logger are to be provided.

(c) A copy of the approval and verification of the design of the mast from a competent structural engineer / institute should be submitted along with the tender.

5. AGREEMENT:

An agreement has to be executed within fifteen days from the date of receipt of Purchase order for the due fulfillment of the tender / contract.

6. PRICE:

The rates quoted should be for fabrication, transportation of masts to the sites in the Leh District of Ladakh region of J&K state along with civil works and installation of the 50 m tall-guyed mast. The details of the sites considered are given in Annexure - D. The exact locations will be decided at later stage and thus the tenderer need to provide cost for each site. The rate quoted should be inclusive of all taxes, excluding excise duty. The rates should be quoted separately for masts fabrication, transportation to each of the sites, civil works and installation (Annexure - E).

7. EARNEST MONEY:

(a) An earnest money of **Rs. 50,000.00** should be deposited along with the tender in form of Demand Draft payable to **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt.** This will be returned to unsuccessful tenderers. The earnest money in respect of successful tenderer will be adjusted against the security deposit. Tenders received without EMD will summarily be rejected.

(b) EMD will be forfeited if the tender withdraws or amends / impairs and derogates from the tender in any respect within the period of validity of tender or fails to furnish the security deposit / agreement as per Clause 5 and 14.

8. TAXES:

As applicable - We are not eligible to issue C or D form.

9. PAYMENT:

- (i) 50% of the total cost for masts fabrication will be paid after inspection of the material at the works and against submission of bank guarantee from a Nationalized Bank. The bank guarantee should be valid till the completion of work and acceptance.
- (ii) 50% of the total cost for masts fabrication will be paid on receipt of the masts at the sites in good condition and as per specifications.
- (iii) Full transportation cost will be paid on delivery of the masts received in good condition as per specification. The address of the concerned State Nodal Agency officers at the sites is given in Annexure- D.
- (iv) Full civil works and installation cost will be paid on completion of the work i.e. installation (erection) of the 50m mast at the site and on furnishing a certificate from the concerned SNA officer that the work has been completed successfully. Instrumentation of the mast will be carried out by CWET, however the erection of the mast need to be done by the tenderer in the presence of **C-WET** and **LREDA** representatives.

Rates need to be quoted clearly both in figures and words. In case of discrepancy in unit and total prices, unit price shall be taken to be final price for purpose of calculations.

10. INSURANCE:

Quote should be inclusive of premium for transit insurance.

11. GUARANTEE

Should be for a period of minimum one year for manufacturing defects and materials. During the warranty period, if there is manufacturing and other technical defects of the materials / equipment supplied, the supplier/contractor should arrange for replacement at their cost. Otherwise, the supplier/contractor shall be liable for a penalty of one percent per week during breakdown period on the total contract price. The warranty will have to cover all the materials and goods supplied by the supplier under the contract irrespective of the fact whether these have been manufactured by the supplier/contractor or not. A model form of warranty is furnished below:

The contractor /seller hereby declares that the goods/ stores / articles sold to **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** under this contract shall be of the best quality (and workmanship) and shall be strictly in accordance with the specifications and particulars contained / mentioned in the clause / Annexure – B here of and the contractor / seller hereby guarantees that the said goods / stores / articles would continue to conform to the description and quality aforesaid for a period of 12 months from the date of delivery of the said goods / stores / articles to **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** and that not with standing the fact that **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** (or any officer authorized in this, behalf) may have inspected and / or approved the said goods / stores / articles. If during the aforesaid period of 12 months the said goods / stores / articles be discovered not to conform to the description and quality aforesaid or have deteriorated (and the decision of **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** in that behalf will be final and conclusive) **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** will be entitled to reject the said goods / stores / articles or such portion thereof as may be discovered not to conform to the said description and quality. On such rejection the goods / stores / articles will be at the seller's risk and all the provisions herein contained relating to rejection of goods, etc., shall apply. The contractor / seller shall, if so called upon to do, replace the goods, etc., or such portion thereof as is rejected by **the Deputy Commissioner/Chief**

Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh, otherwise the contractor / seller shall pay to the **LREDA** such damages as may arise by reason of the breach of the condition herein contained. Nothing herein contained shall prejudice any other right of **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** in that behalf under this contract or otherwise.

12. VALIDITY OF TENDER:

The rates quoted in the tenders should be valid for a period of at least 90 (ninety) days from the date of its opening.

13. SECURITY DEPOSIT:

Acceptance of the Tender constitutes a concluded contract, Nevertheless, the successful tenderer must within a month after the acceptance of his Tender furnish 5% of the amount of the contract as interest free security deposit and execute an agreement at his own cost for the satisfactory fulfillment of the contract. The interest free security deposit of 5% will be refunded after the expiry of 3 months from the date of satisfactory completion of the works.

14. WITHDRAWAL OF TENDER

Withdrawal from the Tender after it is accepted or failure to supply within a specified time or according to specifications will entail cancellation' of the order and purchases being made at the officer's expense from elsewhere, any loss incurred thereby being payable by the defaulting party, In such an event **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** reserve also the right to remove the defaulter's name from the list of approved suppliers permanently or for a specified number of years.

15. ENHANCEMENT OF PRICE:

No representation for enhancement of the price once accepted will be considered.

16. CANVASSING:

Any attempt on the part of tenderers or their agents to influence the officers concerned in their favour by personal canvassing will disqualify the tenderers.

17. LICENSE / PERMIT:

If any license or permit is required, tenderers must specify in their Tender and also state the authority to whom the application is to be made.

18. SUPPLY OF REQUIRED QUANTITY:

The Tender may be for the entire or part supplies. But the tenderers should be prepared to carry out such portion of the supplies included in their Tender as may be allotted to them.

19. FAILURE OF THE TENDERER TO SUPPLY THE QUANTITY ORDERED:

(a) In cases where a successful tenderer after having made partial supplies fails to fulfill the contracts in full, or any portion / parts be purchased by means of another

tender or by negotiation or from the next higher tenderer who had offered to supply already and the loss, if any, caused to **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** shall thereby together with such sums as may be fixed by **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** towards damages be recovered from the defaulting tenderer.

(b) Even in cases where no alternate purchases are arranged for the materials not supplied, the proportionate portion of the security deposit based on the cost of the materials not supplied at the rate shown in the tender of the defaulter shall be forfeited and balance alone shall be refunded.

(c) Any sum of money due and payable to the contractor (including Security Deposit returnable to him) under this contract may be appropriated by **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt.** or any other person authorized by **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt.** and set off against any claim of **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt.** for the payment of a sum of money arising out of or under any other contract made by the contractor with **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** or any other person authorized by the Centre.

20. MONEY DUE AND PAYABLE:

Any sum of money due and payable to the successful tenderer or contractor from **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** shall be adjusted against any sum of money due to **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** from him under any other contracts.

21. CONDITIONS PRESCRIBED BY THE TENDERERS:

Special conditions, if any, printed on the Tender sheets of the tenderer or attached with the tender will not be applicable to the contract unless they are expressly accepted in writing by the purchaser.

22. DELIVERY:

The masts should be fabricated, transported to the selected sites and installed within 90 days from the date of issue of work order by **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh**.

If the guaranteed delivery period is not kept up the Liquidated Damages specified herein will be enforced. **The Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** is at liberty to alter the delivery period to suit its needs as and when necessity arises, during tendency of the contract.

23. LIQUIDATED DAMAGES:

The delivery / completion period given in clause 'Delivery' shall be guaranteed by the supplier under the following 'Liquidated Damages' clause.

If the supplier / contractor fails to deliver satisfactorily the materials within the time specified in the order/contract or any extension thereof then **CWET** shall recover from the

supplier/contractor as Liquidated damages a sum of 1 % of the contract price for each completed week of delay. The total liquidated damages shall not exceed five percent (5%) of the contract price of the items / materials so delayed.

If supplies / services to be rendered against this contract are made by the contractor beyond the period of delivery stipulated in the contract and they are accepted by **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** such acceptance is without prejudice to the rights to recover liquidated damages for the delay in supply. **The Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** will also be at liberty to cancel the order if the supply is not completed within the stipulated delivery period notwithstanding the Liquidated Damages Clause applicable for the belated supplies.

For any supplies made beyond delivery schedule the increase in statutory levies like Excise Duty, Sales Tax, etc. if any or fresh levies will not be borne by **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh**.

Liquidated Damages will also be recovered for the quantity not supplied as is done for the late supply.

24. LOSSES OR DAMAGE

External damages or shortages that are prima-facie the results of rough handling in transit or due to defective packing will be intimated within a fortnight of receipt of materials. Internal defects, damages or shortages of any integral parts, which cannot ordinarily be detected on a superficial visual examination and which are caused by bad handling in transit or defective packing, would be intimated after inspection on receipt of materials at site. In either case, damaged or defective materials should be replaced, free of cost, to the **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh**.

25. REPLACEMENT OF DEFECTIVE / DAMAGED MATERIAL:

Notwithstanding anything contained in Liquidated Damages clause of this tender / Purchase Order, where the whole or part of the materials supplied by the supplier/contractor are found to be defective or damaged or are not in conformity with the specification such defects or damages in material supplied shall be rectified either at the point of destination or at the supplier's works at the cost of the contractor against proper security and acknowledgement. In the alternative, the defective or damaged materials shall be replaced free of cost within fifteen days on receipt of intimation from the purchaser of such defects or damages. If the defects or damages are not rectified or replaced within this period, the contractor shall pay the liquidated damages at the rate of one percent of contract value of the materials concerned per completed week of delay from the date of receipt of intimation of the defects or damages subject to a maximum of 5% (five percent).

In the event of supplies being received damaged or short at the destination point the cost of such materials with Excise duty, Sales Tax and other charges payable there of will be paid only proportionate to the value of the materials received in good condition unless the damaged goods or short supplies are made good free of cost to **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** by the supplier/contractor.

If during the period of supply it is found that goods already supplied are defective in materials or workmanship or do not conform to the specifications or are unsuitable for the purpose for which they are purchased then it will be open to the purchaser either to reject the goods and repudiate entire contract and claim such loss that the purchaser may suffer on that account or require the supplier/contractor to replace the defective goods free of cost.

26. INSPECTION:

The purchaser or purchaser's representative shall have free access to the supplier's/contractor's works at any time during working hours for the purpose of inspecting the manufacture and testing of the materials covered by this tender/ Purchase Order. The supplier/contractor shall provide necessary facilities for such inspections. Documents like invoices or receipt challans detailing the source of supply of raw materials and their specification shall be shown by the supplier on demand either during the manufacturing process or at the time of inspection from **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh.**

27. FORCE MAJEURE:

If at any time during the continuance of this contract, the performance in whole or in part or any obligation under this contract shall be prevented or delayed by reasons of any war, hostility, acts of public enemy, acts of civil commotion, strikes, lockouts, sabotages, fires, floods, explosions, epidemics, quarantine restrictions or other acts of God (herein after referred to as eventualities) then provided notice of the happening of any such eventuality is given by the contractor to **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** within 15 days from the date of occurrence thereof. Neither party shall, by reasons of such eventuality, be entitled to terminate this contract, nor shall have any claim for damages against the other in respect of such non-performance or delay in performance. Deliveries under this contract shall be resumed as soon as practicable after such eventuality has come to an end or ceased to exist. Provided that is the performance in whole or part by the contractor or any obligation under this contract is prevented or delayed by reasons of any eventuality for a period exceeding 60 days, **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** may at its option, terminate this contract by notice in writing. It is hereby specifically agreed that time is the essence of the contract. The termination of the contract as aforesaid shall not absolve the supplier / contractor of his liability to pay damages to **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh** for the breach of contract to deliver the goods or complete the performance of the contract within the time limit stipulated in the purchase order or extension, if any, given thereof.

28. ARBITRATION:

In the event of any dispute or difference between the supplier/contractor and **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh**, arising out of any item of the tender, contract, purchase order, the same shall be referred to the sole arbitration of the Member Secretary, **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh**, or his/her nominee. It is the condition of this clause that all the hearing of the arbitration will take place at Leh and shall be subject to the jurisdiction of Leh court.

29. ROYALTIES AND PATENTS:

Any royalties or patents or the charges for the use or infringement thereof that may be involved in the contract shall be included in the prices. Tenderers shall protect the purchaser against any claims thereof.

30. RESPONSIBILITY:

The tenderer is responsible for safe transportation of materials to the concerned areas. The tenderer should include and provide for securely protecting and packing the materials as per relevant packing standards to avoid damages or loss in transit.

31. OTHER TERMS AND CONDITIONS:

The supplier/contractor, after accepting the contract shall not transfer or assign or sublet the contract or any part of the contract directly or indirectly to any person or persons whomsoever, without the written consent of **the Deputy Commissioner/Chief Executive Officer, LAHDC, Leh Ladakh J&K Govt./ Project Director, LREDA-LAHDC, Leh-Ladakh.**

ANNEXURE-B

GUIDELINES TO BE FOLLOWED IN THE FABRICATION OF THE 50 M TUBULAR MAST

Aim: To collect the wind velocity data and other meteorological parameters using sensors fixed on the mast at multiple levels generally 10,30 and 50 m above ground. (The exact levels will be informed before packing and dispatch of the materials)

Data:

Length of mast: 50 m

The mast needs to be made up to 50 m using multiple segments generally of uniform length and diameter or it can be of tapered nature. The joining of segments can be either using bolts or clamps or could be sliding type.

Mast Material: The mast material and other components including foundation bolts can be MS pipes (as per appropriate IS) hot dip galvanized or otherwise protected against corrosion. Adequate corrosion protection is necessary as the masts are to be deployed in a highly coastal environment. The protective coat shall be on both ID and OD of the pipe. Corrosion protection shall be last step in the manufacturing process.

Guy wire size: The diameter should be such it is easy to handle at the time of installation and storing. The material should be galvanized steel core wire ropes

Guy Positions: Six level guy wires (with 4 guy wires at each level) with multi guy radii. The mast erection should not require elaborate installation equipments such as cranes or derricks. It should be feasible to install the mast with lightweight crab winch or a pulling & lifting machine. For ease of installation a tilt up mast installation procedure is recommended.

Installation of mast: Using gin pole and with portable lifting machine. The mast should be easy to be installed. The mast should be easy to be lowered and raised.

Civil works: Preferably with simple concrete works for central foundation and guy foundations.

Sensor locations: Wind speed at 10,30& 50 m level (or as specified)
Wind direction 30& 50 m level. (Or as specified)
Temperature sensor at 48 m or 10m. (or as specified)
Solar radiation sensor at 5m level.

Necessary holes are to be provided at the appropriate levels to take the sensor cables inside the mast.

The fabrication of the mast should be in accordance with the certified drawing and specifications.
