As recommended by the Committee vide Assistant Director Tourism, Leh's No: quoted above and in pursuance of the J&K Registration of Tourist Trade Act 1978, after consideration of all other factors, I, Simrandeep Singh (IAS), Deputy Commissioner, Leh fix the following maximum rate of Tariff of Hotels and Guest Houses of different categories to be operative in Tourist area of Leh District for the calendar year 2014.

The rates do not include the Tariff Tax livable and J&K Hotel (Amenities and services) Tariff Taxation Act. 1980.

- a) AP means room with full boarding. MP means room with break fast and Dinner, CP means room with break fast, EP means only room.
- b) 25% discount during lean tourist season w. e. f. 1st October to 30th April (every year).
- c) Heating including other expenses then tariff will be separately.
- d) 40% of the room rent will be charged for extra bed.

The tariff of Hotels and Guest Houses so fixed/framed will be effective from 1st January 2014 to 31st December 2014.
