

2. The bids shall be deposited in electronic format on website www.jktenders.gov.in in from 16-08-2016, 10.00 A.M to 06-09-2016 up to 2.00 P. M. The Technical bids received will be opened in the office of the Deputy Commissioner/CEO, LAHDC, Leh online on 07-09-2016 at 3.00 P. M or any subsequent convenient date.
3. The complete bidding process will be online.
4. Bid documents can be seen at and downloaded from the website www.jktenders.gov.in bid documents containing qualifying criteria for bidder, specification, conditions and other details.
5. The bids must be accompanied by Demand Draft as non-refundable payment of tender documents obtained online Rs. 1000/- for General and Rs. 500/- for SSI Units Registered. EMD in the form of CDRs/FDRs amounting to Rs, 1,00,000/-(Rupees One Lakh only) be pledged in favour of Chairman, District Purchase Committee, Leh. The cost of downloaded tender documents in the form of DD shall be in separate envelop with cover making cost of the documents on or before 06-09-2016 up to 2.00 P.M.
6. Bidders can resubmit/withdraw the bids as specified.
7. The department will not be responsible for delay in online submission due to any reasons.
8. The interest bidder can download the NIT/Bidding document from the website www.jktenders.gov.in
 - a) To participate in bidding process, bidders have to get "Digital signature Certificate" (DSC) as per information Technology Act 2000 to participate in online bidding. This certificate will be required for digitally signing the bid. The bidders, who already possess valid (DSC), need not to procure new digital Signature certificate (DSC).

The Chairman, District Purchase Committee, Leh reserves the right to accept or reject any tender without assigning any reason thereof.


