- b. To participate in bidding process, bidder has to obtain "Digital Signature Certificate" as per the information technology act 2000.
- c. The bidder must not make any change in BOQ (Bill of Quantity). In no case they should attempt to create similar BOQ manually. The BOQ downloaded should be used for filling of the item rate inclusive of all taxes, insurance, installation & transit cost.
- d. The bidders have to submit their bids online in electronic formats with Digital Signature. No financial bid will be accepted in physical form.



- e. The bid shall be opened in the office chamber of Chairman/ DC/CEO, LAHDC, Leh online on the aforementioned day or any other subsequent convenient date.
- f.
